



2025 CAMP PAYMENT POLICY

Payment for all camps is due prior to the start of class and must be processed online.

No refunds are available. We staff camps based on the number of students participating, so please understand that no refunds will be provided after enrollment. If an emergency arises, you may opt to receive a NBPA credit which can be applied to upcoming classes, per authorization from Sherry. Please note: this camp ends in a performance that includes assigned parts, characters and costumes. Please refer to the specific camp description to make sure you are available to be there for the final performance (check dates and times for each camp.)

Make sure to provide your child with: a water bottle, mid-day snack and lunch.

If the camp includes a final Friday performance, please pack extra snacks for your child to eat between the end of camp and the final show.

Please bring/wear shoes you can dance and move in - **no flip flops, sandals, Crocs or open toed shoes.** During the day, we do crafts which may include paint--please bring an old t-shirt or dress accordingly. Please alert us if your child has a food allergy and discuss NOT sharing food and drink for their safety.

NBPA expects students to exhibit good behavior while attending all activities, including camps. Participation is dependent on everyone being kind, respectful and following the rules set forth by instructors. Removal from camp due to unacceptable behavior is up to the sole discretion of NBPA, and will not result in a refund. Thank you for your cooperation!

Safeguarding

Credit card data in our database conforms to the PCI P2PE Standard requirements from the credit card industry. That means we do not store data from credit card transactions such as Track II or CVV2/CID (the 3 or 4 digits on the back of the card). If stored, credit card numbers are securely encrypted and we ask that you never send a complete number to us in emails. PCI compliance means that our database and key internal applications have been tested for security by independent 3rd party auditors and approved by the PCI council.

With respect to online security, when we transfer and receive certain types of sensitive information such as financial information, we redirect visitors to a secure server. We have appropriate security measures in place in our physical facilities to protect against the loss, misuse or alteration of information that we have collected from you at our website.
